It seems as though Council haven't followed its land disposal policy correctly. Being land vested in Council as a public work, it should have been offered back to the previous owners (or their descendants) to purchase at full market value, not for free, prior to declaring the land as surplus. There is a clear procedure to follow that seems to have not been followed in this case, which would open Council to judicial review. I would suggest the resolution is rethought, in the context of the land disposal policy, which was developed in full consultation with Te Tatau o Te Arawa. And bring it back to the table when that has been completed.

I previously made submission yes, but I've changed this to no. I live at [redacted] and I had not seen/read the letter to to neighbouring residents until now to read of the history. I see all the waka ama boats on the side of the road plus a shipping container at the end of Parawai Road. I think it would be a more fitting use of the land if it was rented to the waka ama club for a tiny amount \$100 per year. This would allow them to store all their boats on this section of land. Also I would like the council to make access across the road for launching a bit easier if possible for wheeled trailers and such. The reserve across the road is NOT up for discussion, but it would be good for the council to consider erecting a covered space (oversized carport) to provide shelter from sun and rain. Picnic tables and ablution block. Other clubs such as the rowing club often come down to this end of the lake as part of their training. The sailing club sometimes does destination sails such as sailing around the Island. So there are several other clubs that might use the lakeside reserve as a destination and the unused piece of land we are discussing across the road could be a useful carpark and waka ama park. If the Waka Ama club eventually wanted to build a clubhouse on the land in the future this is something that could be considered if their rent was increased to the same level as the rates of surrounding properties. By the way I have no affiliation to the Waka Ama club but I am a member of the sailing club.

We all want to be considerate to people who might not like dogs. I'm well aware that finances are tight with council at the moment, however I believe that if the council is pro-active, this certainly wouldn't need to be high cost. I'm sure that we could approach Mitre 10, Bunnings or another Rotorua business who may be able to help with providing timber/nails etc, and why not use recycled materials also to make the obstacle course. On a side note, Toi Ohomai have a new Joinery / Allied Trades course and I'm sure if the Council supplied the materials for this project why not approach Toi Ohomai who could use this project as a learning opportunity for students. They could build/create the space. This would give them confidence and pride in what they have achieved in the area. It may even be possible for some of the locals to come to the party who have building experience. These businesses, organisations and people who help with the project could perhaps get a nice little board of promotion up on the fence somewhere.... thanking them for their contribution. 1. I write on behalf of my direct descendants and wider Leonard whanau to support the view that this land stated above should be declared surplus to Council requirements and be returned to the descendents of the original owners.
2. For clarity I am aware that this area of land and one opposite namely where Council utilities are found are under one title but I refer only to the area set out above.
3. I am a grandchild of Ranginui and Heketoro Leonard and I have lived next to this land for over 60 years. I currently live at
4. This piece of land was originally a part of our whanau farm belonging to Kui Ranginui and Koro Heketoro located between Leonard and Ranginui Street. I know this to be true in that as a child, the farm surrounded our house at and this area was paddock. I played there, ran to my uncles home through there, chased cows and sheep there and cleared the drain when it flooded!! There were no other houses on our side of Ranginui Street at the time. The land there was very swampy because of the watertable and springs found across the farm.
5. Having lived next to this piece of land most of my life I can say that it has never been used by anyone other than whanau members, so has simply remained a vacant lot that is mowed regularly by the Council. It has been used as a place that our tamariki and mokopuna have played on and where we put down our whanau Xmas hangi!!!
6. I can only assume that the reason people other than whanau have not been on it is that it has never been sign posted and may well have been viewed as private land.
7. It is my understanding that in the late 1950's, the land was surveyed. Our kuia and koroua made sections available to their children living within the district as well as providing for the eldest of mokopuna at that time. Members of the whānau still retain and live on those sections provided for them or our parents. Nos Street are currently occupied by descendants of Ranginui and Heketoro, while remain in whānau hands.

8. Added to these are the dwellings at _____ Road. The point I make is that this area has a close connection to our whānau while also confirming that the whole area was a part of the original whānau farm.
9. Council records show that the land was vested in Pakeke Heketoro Leonard our uncle in order to on vest in Nov 1955. In August 1962, the sections involved here were transferred from Pakeke Heketoro Leonard to the Council, and no monetary consideration was stipulated in any documentation. This must be considered a generous offer especially when one considers that nearly all of the lakeside properties opposite our whanau farm belonged to non-Māori except for sections given by our grandparents.
10. Council officials know how the land was transferred but not why. Some suggest that it was the done thing to designate reserves for public use when surveying thereby removing those sections from a future sale.
11. Another view I wish to offer is that our grandparents were significant figures in their time in the Ngongotaha and Waiteti communities. They were major land owners, all of their children were raised in this community before moving away, we have close ties to Ngararanui and Ngāti Rangiwewehi, our grandfather was an original member of the Te Arawa Trust Board followed by his son Pakeke who became Chair as well as Deputy Mayor of Rotorua. Sharing a piece of land they had for the betterment of the community makes sense.
12. On the reverse side, the land could well have been designated to a member of our whānau for our use, but that never happened. Things have changed a lot since those early days where now, land is an important commodity especially whanau land.
13. We have descendants who want land to settle. We are clear in the view that this land will never be alienated from the whanau if and when we have it returned.
14. Finally in terms of the local iwi, I have attached a letter from Mr Wallace Haumaha, Chairman of Ngararanui in support of our association to the land.
15. I wish to speak to my submission and ask that the hearing take place at Waiteti marae.

This novaflo goes down the side of our section [redacted] and catches the water from neighbours who have their downpipes going into our section, it also takes water from the corner of [redacted] and we have novaflo that takes water from [redacted] as the down pipes from there also comes onto our section. We have a number of soak holes as required when we built both houses.

Every 2nd year we get a pipe cleaning contractor to run a cleaning (rat) up the pipe to ensure that it continues to work as expected and we would like to have continued access to do this...also if it does get built on we would like continued access and that the drainage is not damaged, it is possible to have this noted on the land details.

It appears that it is already considered iwi land as there are people camping over Xmas and Leo manages to "spread out" on it making it pretty hard for the council to move!
