## 1. TE PŪTAKE PURPOSE

The purpose of this report is to update the Rotorua Community Board members on recent developments in regard to the renovation of the Mamaku and Reporoa Community Halls and to ask for the Board's approval to allocate devolved funding for associated items.

## HE TŪTOHUNGA RECOMMENDATION

- That the report 'Devolved Funding Decisions: Mamaku and Reporoa Community Halls' be received.
- 2. That the Committee resolve to allocate \$4,358 of devolved funding towards the purchase and installation of blinds for the Reporoa Community Hall.
- 3. That the Board resolve to allocate the final balance of devolved funding (\$6,242) from the 2024/25 budget towards the purchase and installation of heat pumps for the Mamaku Hall, noting that this will be added to the \$14,240 already allocated.
- 4. That the Board note that further funding may be required to purchase the heat pumps for the Mamaku Hall and approve the reallocation of up to \$5,000 of devolved funding currently allocated for the purchase of heat pumps for Reporoa Community Hall, to the purchase and installation of heat pumps for the Mamaku Community Hall, if required.
- 5. That the Board note that funding currently allocated to the Reporoa Community Hall for the purchase of heat pumps will be insufficient, and that the Board will be asked to allocate funding from the devolved funding budget 2025/26 to supplement funding already allocated for the purchase and installation of heat pumps at the Reporoa Hall.

# 2. TE MATAPAKI ME NGĀ KŌWHIRINGA DISCUSSION AND OPTIONS

The update below relates to information that has become available to the Chair of the Rotorua Rural Community Board (the Board) since the last meeting of the Board on 18 March 2025.

#### 2.1. Request for blinds for the Reporoa Community Hall

The Chair of the Board has received a request, via Cr Barker, from representatives from the Reporoa Community asking for information on applying for devolved funding to purchase blinds for the Reporoa Community Hall.

The blinds will replace curtains that had previously covered the windows on the north side of the building above the Memorial Wall. The blinds are seen as a better option as they can be treated for mould resistance and will not cover the Memorial wall display as the curtains currently do.

As surplus devolved funding is still available and a quote had been obtained, the Board is being asked to consider allocating funding as soon as possible, so that the blinds can be purchased and potentially installed prior to ANZAC Day, 25<sup>th</sup> April.

Access to the Hall is currently limited due to the renovations and the continuing treatment required to eliminate mould. It has been agreed that community members will have temporary access to the hall for their ANZAC Day preparations on the 23<sup>rd</sup> and 24<sup>th</sup> April and it may be possible to install the blinds over this period.

Following the ANZAC day commemorations the Hall will close again for further renovations.

#### 2.2. Purchase and installation of heat pumps at Mamaku and Reporoa Community halls

Further information has become available about the purchase and installation of heat pumps for the Mamaku and Reporoa halls. New quotes are required for both halls and recent advice indicates that costs for purchasing and installing the heat pumps are likely to have increased significantly and that the current devolved funding allocated to each hall (\$14,240 respectively) will be insufficient.

Both halls are under renovation, however the Mamaku Hall is sufficiently progressed for quotes to be obtained to purchase and install heat pumps in the near future. The Reporoa Hall will close again after its temporary opening for ANZAC Day and it will be some time before there will be access to the building for quotes to be obtained.

Given the information above, Community Board members are being asked to consider and approve progressing the installation of the heat pumps in the Mamaku Hall, by committing the surplus funding from this year's devolved funding budget (\$6,242) to supplement the funding already committed. The Board is also asking that should the cost of purchasing and installing the heat pumps exceed this amount (\$20,482), that funding of up to \$5,000 be re-allocated from Reporoa Hall's heat pump funding allocation to the Mamaku Hall.

A further consideration that the Board is being asked to note is that even if funding is not re-allocated from the Reporoa heat pump allocation to the Mamaku allocation, there will still be insufficient devolved funding to purchase and install heat pumps in the Reporoa Hall when the building renovations are completed. Therefore the Board has been asked to note that a request will be made that supplementary funds are allocated from the 2025/26 devolved funding allocation for this purpose.

Re: Replacement roller blinds - East wall high windows

Thank you for the opportunity to submit our quotation to supply, manufacture and install light filtering rollershades to the Reporoa Community Hall. The width of the windows exceeds the width of the fabric, so will require 2 blinds per window. We recommend a set 20 as per diagram attached – 2 blinds linked with 1 chain control. There is a wide range of fabrics available, and we recommend a light filtering fabric as opposed to block out and can readily supply samples for approval.
