The installation costs by RLC would be \$1,500. (\$300 per site) for a total of \$8,350. Additional/spare throw bags could be purchased to cover lost or damaged items.

- Cr Barker commented that the board needed more access to reports e.g. condition of halls
   & programmes of maintenance works required.

Mr Guyton commented that a lot of equipment & materials not belonging to RLC had mould damage and had been disposed of by the contractor working on the interior of the Reporoa Memorial Hall.

#### Comprehensive Stormwater Consent approved

- This consent amalgamates 39 individual consents into 1 overarching consent that is
  managed by Rotorua Lakes Council. This consent outlines the requirements for work in
  the catchment over the next 30 years.
- There is a License Manager in Council in charge of the consent and t expires in 2059
- There are approx. 200 industrial sites that are identified as "high risk" and will need to get a license to discharge into the SW system.
- There will be education on responsibilities and monitoring and compliance aspects to the consent.
- A Rotorua Urban Water Quality Plan will be finalised within 12 months and the consent will be monitored in line with the WQP. Results will be published online.

# **Rotorua Urban Catchment Area Map**



### Tarawera Sewerage Scheme Funding Workshop with BOPRC

### Rates Swap Proposal

- BOPRC have committed to reducing their targeted rate to Rotorua residents (replacing with a general rate across the Bay of Plenty) over the next 3 years.
- Rates that Rotorua residents are paying to the Regional Council are reducing with NO change in service.
- This creates an opportunity for RLC to increase its Lakes Enhancement Rate (over the same timeframe as the Regional Council rate reduction) to increase the subsidy for the Lake Tarawera Sewerage Scheme and to repay the recent \$10 million loan for the Rotoiti Sewerage Scheme, as required by 2032. Limiting the net effect to Rotorua ratepayers.



Additionally, a potential for interest free loan agreement with Regional Council.

- Requires approval by Regional Council.
- Would require negotiation of a suitable agreement.
- Finalise by May 2025 to ensure provided for in Regional Council's Annual Plan 2025-2026.

### Attachment 2: Letter from Reporoa resident, Mattew Fitzgerald

Reporoa Community Issues & Proposed Solutions
Prepared for Rotorua Lakes Council
By Matthew Fitzgerald

### 1. Clarification of Council Responsibilities

One of the key challenges faced by the Reporoa community is understanding the roles and responsibilities of the various council departments and governing bodies.

At present, my understanding is that responsibilities are divided among the Domain Board, Parks and Reserves teams, and the broader Rotorua Lakes Council. However, it is unclear which entity is responsible for specific issues or improvements.

### Proposal:

 We request a clear breakdown of responsibilities, including a directory or contact list of the relevant departments.

### 2. Vaile Road & Reporoa Domain Entry Repairs

The entrances to Vaile Road Reserve and Reporoa Domain have deteriorated over time, leading to water pooling during periods of rain. These areas serve as key access points for recreational use, and their current condition presents safety concerns.

### Proposal:

- Conduct a formal assessment of these entryways and identify necessary repair work.
- Upgrade the entrances to meet current council safety and accessibility standards.
- Improve drainage to prevent future pooling and maintain usability year-round.

### 3. Broadlands Road Maintenance and Widening

Broadlands Road is a critical arterial route, used extensively for events such as the Ironman and local cycling training. However, the road has limited or non-existent cycle lanes, making it increasingly hazardous, particularly as traffic volumes continue to rise.

The combination of large vehicles (tractors, trucks) and cyclists sharing narrow lanes presents a significant safety risk. While event-day closures help mitigate these risks temporarily, the concern remains for regular usage.

### Proposal:

- Undertake a traffic safety review for Broadlands and Vaile Roads.
- Implement road widening as part of any scheduled maintenance or upgrades.
- Designate and mark dedicated cycle lanes to enhance safety for all road users.
- Investigate funding opportunities for these improvements, possibly in partnership with national transport agencies or event organisers.

### 4. Reporoa Waste Management & Septic System Concerns

Reporoa's geographical position as a low-lying village presents challenges for waste management, particularly during wet winter and spring months. When the ground becomes saturated, septic systems fail to function effectively, leading to concerns about public health and environmental contamination.

Given the proximity of the Waiotapu Stream, there is a real risk of untreated waste entering the waterways, which poses a significant environmental threat. Additionally, homeowners and businesses face costly individual solutions, with estimates as high as \$30,000 to mitigate septic seepage that in turn may not even work.

#### Proposal:

- Conduct an independent environmental impact study to assess the severity of the issue.
- Explore funding or subsidy options for residents who need septic upgrades.
- Investigate the feasibility of a community wastewater treatment solution.
- Engage with the Regional Council to explore long-term waste management solutions that protect local waterways.

### 5. Water Safety Signage & River Management on the Waikato River

The Waikato River is a popular recreation spot for both locals and visitors, yet key areas along the river lack adequate safety signage or speed restriction notices. This poses a risk to swimmers, boaters, and other users who may be unaware of potential dangers.

Currently, it is unclear whether responsibility for river safety falls under the jurisdiction of the local council or the regional council.

### Proposal:

- Clarify which governing body is responsible for managing water safety initiatives on the river.
- Install appropriate safety signage at high-use areas to warn about hazards.
- Assess the feasibility of implementing speed restrictions in key areas to reduce the risk of accidents.
- Promote community awareness campaigns to educate visitors and locals on water safety best practices.

#### Conclusion & Call to Action

The Reporoa community is seeking clarity, action, and investment in these key areas to ensure the safety, well-being, and sustainability of the region.

We kindly request:

- 1. A response regarding the breakdown of council responsibilities.
- 2. A formal review of the proposed infrastructure improvements, including road widening and entryway repairs.
- 3. Further engagement on long-term waste management solutions.
- 4. Immediate action on water safety signage and management along the Waikato

We appreciate your time and consideration in addressing these community concerns and look forward to working together to implement practical solutions.
